



**Bradford Safeguarding Children Board
Multi-agency Training Programme
April 2017 to March 2018**



Introduction

The courses run by the Bradford Safeguarding Children Board are delivered to a multi-agency audience which means that professionals from different organisations and backgrounds join together for a shared learning experience with an emphasis on building relationships and working together to help them safeguarding and promote the welfare of children and young people.

This document contains details of all multi-agency training courses planned for the year 1st April 2017 to 31st March 2018 with dates, times and any entry requirements.

Course Pre-requisites

Anyone applying for our face to face courses must have done our '**Awareness of Child Abuse and Neglect**' e-learning package or some form of face to face basic child protection training. Please see the course details for any other individual course pre-requisites.

Most courses run from 9.30am to 4.30pm, with registration from 9am and our half day courses 9.30am to 12.30pm. This will be stated on the course flyer and confirmation e-mail. Please ensure you can attend the whole course prior to booking.

Course Cancellation Charging Policy

The demand for places on training courses is high and we want to make sure every place booked is a place used.

We incur costs in order to provide courses and need to be assured that we are spending our budget wisely.

A cancellation charge will be applied for all places unless:

- Notice of the need to cancel the place has been received by the BSCB Training Administrator [by email or telephone] at least 5 working days prior for ½ and 1 day courses or at least 10 working days prior for 2 day courses.
- You/your agency have identified a suitable substitute to attend in your place.

In the event of sickness or other unexpected reason for absence on the day, it is a line manager's responsibility to find an appropriate replacement to attend.

Child Sexual Exploitation - A Resilience Approach for Families

This full day course will be of use to staff/professionals from a variety of agencies and services who work with young people and/or their families who may be at risk of child sexual exploitation. This participatory training uses real life experiences to enable an understanding of child sexual exploitation, its impact on families, and explains young people's responses to CSE. Core Groups - Making them work in a Child Protection Case

It is an important course for all staff **new** to the child protection processes and for those with **experience** who would benefit from an update to refresh their knowledge and skills. This **2 day** training is aimed at all **safeguarding leads, practitioners** and their **managers** from the BSCB partner agencies who are involved on an interagency basis in in-depth **safeguarding assessments and decision making** e.g. core groups, case conferences, in particular those who have responsibility for making or contributing to assessments of risk and need, and evaluation of parenting capacity, in safeguarding contexts. This half day course aims to assist **managers and other staff with responsibility for recruitment** to understand the key features of staff recruitment that help deter or prevent the appointment of unsuitable people; be aware of policies and practices that minimise opportunities for abuse or ensure its prompt reporting; help participants begin to review their own and their organisations' policies and practices in recruitment with a view to making them safer.
