



Boy 10, Seriously Injured in Accident



A 10 year old boy is fighting for his life in hospital after being knocked down by a car.

James Smith was playing on his scooter with two friends near to his home.

The two other boys were not hurt. It appears that the boys were playing in the road when the accident occurred.

A neighbour said the boys always play in the street as their parents do not allow them to go to the nearest park alone. They also stated that there had been a number of ear misses in recent weeks and it was only a matter of time before someone was hurt.

Mrs Rehman, an eye witness said, "I was cleaning my windows at the time so I saw everything. The boys were on and off the pavement as usual, the car turned into our

road and James popped out from between parked cars.

That's when the car hit him.
There was a loud bang and
the little lad screamed out in
pain."

The driver who had only just passed his test, did not want to speak to us and is being interviewed by the police.

A statement by the hospital confirmed that the boy is in a serious but stable condition.
